Lydia A. Bazzano, MD, PhD, MPH

Lynda B. and H. Leighton Stewart Professor of Nutrition Director, Center for Lifespan Epidemiology Research Tulane University School of Public Health and Tropical Medicine

Dr. Bazzano is the Lynda B and H. Leighton Stewart Professor of Nutrition in the Department of Epidemiology at Tulane University's School of Public Health and Tropical Medicine and Director of Tulane's Center for Lifespan Epidemiology Research. She received a Bachelor of Science degree in biology from Newcomb College and earned her MPH, PhD, and MD from Tulane University. She completed her internship and residency at Beth Israel Deaconess Medical Center, Harvard Medical School, and is board certified in Internal Medicine. Dr. Bazzano's research focus is the study of nutrition and its influence on chronic disease over the life course. She has led a number of NIH-funded research studies that explore dietary interventions for weight loss and the reduction of vascular risk factors, producing more than 200 peer-reviewed publications as first author or co-author. Dr. Bazzano served on the 2020-2025 Scientific Advisory Committee to the Dietary Guidelines for Americans. Her work on the macronutrient composition of weight loss diets has garnered attention from major media outlets including the New York Times, Time magazine, and National Public Radio.
